WORK SESSION

a) O-20-233 Budget Amendment for 2019

a) Public Works: 2019 Sign Replacement Project - Change Order 1

<u>Threadgill</u>: The change order you have before you, if approved, will reduce the original September 19, 2019 Highway Services, Inc. signage replacement contract price of \$40,756.92 by \$4,773.82 for a final cost of \$35,983.10. The most significant cost-savings was realized by reusing sign posts that were still in good condition. Staff recommends approval of the change order.

McDaniel made a motion to approve the change order to reduce the value of the sign replacement contract with Highway Services, Inc. in the amount of \$4,773.82 for a total contract price of \$35,983.10 and to authorize the mayor to execute the change order. Hammond seconded the motion. All were in favor and the motion passed.
